

Privacy Statement

BIO-CHEM FLUIDICS is committed to protecting your privacy. Please read the BIO-CHEM FLUIDICS Online Privacy Statement below and also any supplemental information listed to the right for additional details about particular BIO-CHEM FLUIDICS sites and services that you may use.

This BIO-CHEM FLUIDICS Online Privacy Statement applies to data collected by BIO-CHEM FLUIDICS through the majority of its Web sites and services, as well as its offline product support services. It does not apply to those BIO-CHEM FLUIDICS sites, services and products that do not display or link to this statement or that have their own privacy statements. Some products and services mentioned in this statement may not be available in all markets at this time.

Collection of Your Personal Information

At some BIO-CHEM FLUIDICS sites, we ask you to provide personal information, such as your e-mail address, name, work address, or telephone number.

We may collect information about your interaction with BIO-CHEM FLUIDICS sites. For example, we may use website analytics tools on our site to retrieve information from your browser, including the site you came from, the search engine(s) and the keywords you used to find our site, the pages you view within our site, your browser add-ons, and your browser's width and height. We may also use technologies, such as cookies and web beacons (described below), to collect information about the pages you view, the links you click and other actions you take on our sites and services. Additionally, we collect certain standard information that your browser sends to every website you visit, such as your IP address, browser type and language, access times and referring Web site addresses.

When you receive newsletters or promotional e-mail from BIO-CHEM FLUIDICS, we may use web beacons (described below), customized links or similar technologies to determine whether the e-mail has been opened and which links you click in order to provide you more focused e-mail communications or other information.

Use of Your Personal Information

BIO-CHEM FLUIDICS collects and uses your personal information to operate and improve its sites and services. These uses may include providing you with more effective customer service; making the sites or services easier to use by eliminating the need for you to repeatedly enter the same information; performing research and analysis aimed at improving our products, services and technologies; and displaying content and advertising that are customized to your interests and preferences. We also use your personal information to communicate with you. We may send you information about other BIO-CHEM FLUIDICS products and services, and/or share your personal information

with BIO-CHEM FLUIDICS partners so they may send you information about their products and services.

Personal information collected on BIO-CHEM FLUIDICS sites and services may be stored and processed in the United States or any other country in which BIO-CHEM FLUIDICS or its affiliates or subsidiaries maintain facilities.

Sharing of Your Personal Information

Except as described in this statement, we will not disclose your personal information outside of BIO-CHEM FLUIDICS and its controlled subsidiaries and affiliates without your consent. See the Communication Preferences section below for more information.

We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, hosting websites, processing transactions, or performing statistical analysis of our services. Those service providers will be permitted to obtain only the personal information they need to deliver the service. They are required to maintain the confidentiality of the information and are prohibited from using it for any other purpose. We may access or disclose information about you, including the content of your communications, in order to: (a) comply with the law or respond to lawful requests or legal process; (b) protect the rights or property of BIO-CHEM FLUIDICS or our customers, including the enforcement of our agreements or policies governing your use of the services; or (c) act on a good faith belief that such access or disclosure is necessary to protect the personal safety of BIO-CHEM FLUIDICS employees, customers or the public. We may also disclose personal information as part of a corporate transaction such as a merger or sale of assets.
