

# Privacy Statement

BIO-CHEM FLUIDICS is committed to protecting your privacy. Please read the BIO-CHEM FLUIDICS Online Privacy Statement below and any supplemental information provided for additional details about products or services that you may use.

This BIO-CHEM FLUIDICS Online Privacy Statement applies to data collected by BIO-CHEM FLUIDICS through its Web sites and services, as well as its offline product support services. ## **Collection of Your Personal Information**
